### COUNCIL BRIEFS

- Mulgoa RFS station will stay on its current site after changes to the State Environment Planning Policy and not the originally proposed site in Mulgoa Park.

To build the larger station, an access road between The Straight and Mulgoa Roads will need to be permanently closed. Council and the Roads and Maritime Services are now progressing a Traffic Management Plan for approval. Work on the upgraded station will start once the road is closed and will then be completed within 12 months.

- Is your pet registered? Pet registration is an important part of their care and is a legal requirement for all pets to be registered by six months of age. Registering them with the NSW Pet Registry means that if your pet ever gets lost, they'll be safely returned to you when found.

In order for your pet to be registered, they'll need to be microchipped by a vet. The microchip has a unique number that can be read with a scanner and is stored with your personal information (such as name, address and phone number) on the registry's database. Once your pet is microchipped, you can then register them. Registration is a separate process that can be completed online at [petregistry.nsw.gov.au](http://petregistry.nsw.gov.au) or at Council.
